**Representation:** Organizations affiliated with the American Federation of Labor and Congress of Industrial Organizations that comply with the Laws of the council and have its per capita tax paid in full shall be entitled to representation in the Florida AFL-CIO.

**Per Capita Tax:** The monthly per-capita payments shall be paid to the Florida AFL-CIO at eighty (80) cents per member per month. Per capita tax payments shall be due and payable on the first of each month and shall be based on the local's membership during the previous month including the CLC breakdown by member for each CLC jurisdiction. Payments may be made monthly, quarterly, or yearly beginning with 1<sup>st</sup> of month, 1<sup>st</sup> of quarter, or 1<sup>st</sup> of year.

Local or statewide councils shall pay the Florida AFL-CIO the sum of fifty (50.00) dollars annually, due and payable at the beginning of each year.

**New Affiliations:** Local Unions desiring to affiliate shall pay one (1) month's per capita tax at the time of affiliation, based on their previous month's membership.
